Upon presentation of a copy of this court order, issued in compliance with 45 C.F.R. 164.512, to any agency, hospital, organization, school, person, or office including but not limited to the Clerk of Court, human service agencies, public children services agencies, private child placing agencies, pediatricians, psychiatrists, other physicians, psychologists, counselors, or law enforcement agencies, the Guardian ad Litem shall be permitted to inspect and copy any records including activity logs, cancellation notes and/or observation notes from any supervised parenting agency including treatment for physical and mental illness, and/or drug abuse, and/or AIDS (Acquired Immunodeficiency Syndrome), and/or the results of an HIV test or the fact that an HIV test was performed, relating to the child without the consent of the child or the child's parent(s), legal guardian(s) or custodian(s), and to discuss with the person providing the treatment or tests in issue all matters pertinent to treatment and findings related to the child(ren).
