IF THE CHILD IS ADJUDICATED ABUSED, NEGLECTED OR DEPENDENT AND THE COMPLAINT SEEKS AN ORDER FOR A PLANNED PERMANENT LIVING ARRANGEMENT, AN ORDER FOR A PLANNED PERMANENT LIVING ARRANGEMENT WILL CAUSE THE REMOVAL OF THE CHILD FROM THE LEGAL CUSTODY OF THE PARENT, GUARDIAN OR OTHER CUSTODIAN.

ANY PARTY IS ENTITLED TO BE REPRESENTED BY AN ATTORNEY AND UPON REQUEST THE COURT WILL APPOINT COUNSEL OR DESIGNATE THE FRANKLIN COUNTY PUBLIC DEFENDER TO PROVIDE LEGAL REPRESENTATIVE IF YOU ARE INDIGENT.
