Upon presentation of a copy of this Court Order issued in compliance with ORC 2152.55, 45 C.F.R 164.512, 42 C.F.R. Part 2, ORC 2151.14 and .141, to any agency, hospital, organization, school, person, or office including but not limited to the Clerk of Court, human service agencies, public children service agencies, private child placing agencies, physicians, psychologists, counselors, therapists, social workers, or any licensed professional, the evaluator shall be provided *expedited* access to all relevant private and public records related to the child, to include competency evaluations; reports conducted in prior delinquent child proceedings; confidential communications made by the child to a program in the course of diagnosis, treatment, or referral for treatment; treatment plans and summaries; treatment progress; treatment progress notes; medication lists; mental health assessments; psychological reports, testing, and notes; psychiatric evaluation and psychiatric notes; psychosocial history; physician orders; admission and discharge summaries; nursing assessments, and all other available records. This shall also include the disclosure of information previously obtained from other sources which was provided to you in the performance of any of the services or treatment indicated herein, and as permitted pursuant to 42 C.F.R. Part 2.

The consent of the child, parent, legal guardian or custodian is not required to release this information to the above-named evaluator, as this order supersedes such requirement.

The above-named evaluator shall maintain any information received from any such source as confidential, and will not disclose the same, except as the Court directs, and as authorized by law.

The above-named evaluator shall provide any necessary notices of privacy practices for protected health information pursuant to 45 C.F.R. 164.520.

This Court Order requiring the release of records is to remain in effect until the final disposition in this matter, but in no event more than 180 days from the file stamp date hereon.
