**ENTRY/ORDER FOR MEDIATION SERVICES**

Pursuant to Local Domestic Rule 22, it is hereby ORDERED the parties shall participate in mediation assessment and, if determined appropriate, at least one mediation session.

**Parties shall contact the Dispute Resolution Department within ten (10) business days to complete mediation intake, screening, and scheduling.**

**NOTICE:** Mediation sessions are scheduled after the initial screening and intake process is completed by all parties. Failure of a party to complete intake or attend mediation may result in a delay of the case, dismissal of the non-participating party's complaint/motion, or the Court may impose other sanctions at its discretion.
