IF THIS WARRANT IS BEING ISSUED ON COMPLAINT, THE SIGNING NEUTRAL AND DETACHED JUDGE OR MAGISTRATE FINDS THAT PROBABLE CAUSE/SUFFICIENT INFORMATION EXISTS FOR THE ISSUANCE OF THIS WARRANT TO ARREST BASED UPON STATEMENTS IN THE COMPLAINT, AND/OR U-10-100, AND/OR THE AFFIDAVIT OF PROBABLE CAUSE. THE FRANKLIN COUNTY JUVENILE DETENTION CENTER (JDC) SHALL FIRST DETERMINE THE NEED FOR CONTINUED DETENTION BASED ON AN ASSESSMENT OR ANY OTHER RELEVANT INFORMATION. IN THE EVENT THAT THE JDC DETERMINES THERE IS NO NEED FOR DETENTION THE CHILD SHALL BE RELEASED TO CUSTODIAN OR FCCS FOR FCCS TO TRANSPORT TO CUSTODIAN, GUARDIAN OR CUSTODIAN'S HOME. THE COURT RESERVES THE RIGHT TO RESCIND THE RIGHT TO RELEASE FOR TRANSPORT.
