YOU ARE HEREBY ADVISED THAT THE GRANTING OF PERMANENT CUSTODY OF THE ABOVE NAMED CHILD(REN) PERMANENTLY DIVEST THE PARENTS OF THEIR PARENTAL RIGHT AND PRIVILEGES. IF FRANKLIN COUNTY CHILDREN SERVICES OBTAINS PERMANENT CUSTODY OF THE ABOVE-NAMED CHILD(REN), THE PARENTS WILL HAVE NO LEGAL RIGHTS TO THE CHILD(REN). AT THAT TIME, THE CHILD(REN) MAY BE PLACED FOR ADOPTION.

ANY PARTY IS ENTITLED TO BE REPRESENTED BY COUNSEL IN THIS PROCEEDING IF YOU WISH TO BE REPRESENTED BY AN ATTORNEY AND YOU ARE INDIGENT (UNABLE TO PAY FOR AN ATTORNEY), THE COURT WILL APPOINT AN ATTORNEY TO REPRESENT YOU.
